

## MOBILE SEED TREATER SIGNAGE CHECKLIST

### Know the signs – and where to put them!

Protocols from the Agrichemical Warehousing Standards Association (AWSA) require mobile seed treaters to maintain appropriate and informative signage on their equipment. Use this checklist as a guide to help ensure the right signs are posted clearly, and in the **right** place.

#### IMPORTANT:

All signs, whether for portable or fixed treatment and storage facilities, must be clear, concise, and plainly visible. Ensuring employees understand and are aware of signage – as well as the materials/locations/information they identify – are also part of good training policies.

**REQUIRED SIGNAGE for mobile storage and seed treatment units:**

SIGNAGE	IMPORTANCE	LOCATION + VISIBILITY	STATUS	NOTES
Emergency supply cabinet	Required	Post indicators in close proximity to the storage and seed treatment unit.	Yes No	
Fire extinguisher locations	Required	Ensure indicators are plainly visible by operators and those in proximity to the mobile unit.	Yes No	
SDS (MSDS) information (for first-responders)	Required	Ensure sign is plainly visible and the information is easily accessible.	Yes No	
Emergency contact information	Required	Ensure sign is plainly visible and the information is easily accessible. Additional copies can be included in other resources.	Yes No	
Spill clean-up equipment	Required	Post indicators in close proximity to the storage and seed treatment unit.	Yes No	
Eyewash stations	Required	Post above all portable and fixed eyewash stations.	Yes No	
Pesticide warning	Required	If concealed compartments storing seed treatment products are present, post nearby	Yes No	

**RECOMMENDED SIGNAGE for mobile storage and seed treatment units:**

SIGNAGE	IMPORTANCE	LOCATION + VISIBILITY	STATUS	NOTES
No food or drink permitted	Recommended	Post on exterior walls of mobile unit, or in the area where mobile unit will be used.	Yes No	
No smoking	Recommended	Post near all building exits, as well as near interior and exterior areas containing combustible liquids or materials.	Yes No	
Exit/Emergency exit	Recommended	These should be placed above all exit doors. Identify exit routes throughout the unit if required.	Yes No
